

# SPRING ARBOR UNIVERSITY

## DECLARATION AND CERTIFICATION OF FINANCES STATEMENT

Regulations established by the United States Immigration Service require a college to have appropriate proof that an international student will have sufficient money to pay his or her college bill for the number of years of study planned. Therefore, Spring Arbor University needs this Declaration and Certification of Finances Statement completed by each international student to indicate how much money the student can provide toward college costs. Once this form is received and the application for admission is accepted, the student will be asked to send Spring Arbor University the first year's tuition and fees, room/board, and miscellaneous costs (or a large part thereof). The money received will be placed in the student's account in the Business Office, and the I-20 can then be issued. Information from the Declaration and Certification of Finances Statement will be entered on the Certificate of Eligibility (I-20), which must be shown to the U.S. Consul by the student to obtain a visa.
